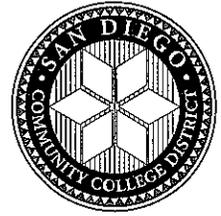

150 REPORT ON COMMUNICATIONS/STATEWIDE & LEGISLATIVE ISSUES

Chancellor Constance Carroll reported on information that is emerging after the Governor issued his May Revise Budget. She indicated the probability that the income revenue from the Governor's tax initiative is overstated, possibly by several billion dollars; that the State's deficit has increased to \$16 billion and rising; and that other areas of anticipated revenue will probably not be realized, especially the revenue projected from the dissolution of redevelopment agencies. She concluded that while the District is in the best situation of many, it is still disappointing to watch the continuing issues unfold.

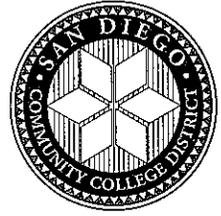
