ACTION ITEMS

Old Business

- 1. UCTCA update from the colleges**
Articulation Officers submitted the UCTCA draft agreements for UC review.
- 2. MOU Lynn Neault's question**
Articulation Officers agreed that the agreement with Howard University doesn't meet the definition of MOU. Articulation Officers prefer to use the process in place for further agreements. Myra Harada will talk to Lynn about sending proposals through the MOU process.
- 3. Transfer Equivalency Project**
Duane Short gave an update on the project. He is working with the English Department Chair to review these courses and will get back to the other colleges. Juliette is working with Liz Armstrong to establish a process for reviewing these courses at Mesa.
- 4. American Institutions Question**
Juliette will contact ASSIST in regards to HIST 175.
- 5. CSU Transferability Criteria**
Duane uses the following guidelines: Guideline for Baccalaureate level courses from CIAC and the CIC guidelines. He also looks for comparable courses in other California community colleges and CSUs. Juliette said that sometimes Iris Gorzolla, Articulation Analyst from SDSU questions our courses that are numbered at the baccalaureate level but don't meet the requirements. Juliette will try to get Iris to talk to the Curriculum Committees in regards to transfer level of courses and implications of inaccurately identifying courses.

New Business

6. Update on lead colleges for MOU proposals

Miramar is the lead college for: Alliant, Embry Riddle and Southern Illinois University Carbondale. Mesa is the lead college for Indiana (Juliette is not sure about the status and will check with Naomi Grisham), and City is the lead for Webster University. Capella and National University are up for renewal late 2007, North Central is up for renewal in 2008.

7. LDTP submissions

Juliette is meeting with Liz Armstrong on how to approach Mesa regarding the submissions. There are various submission deadlines: October, February and June. The hard deadline is 2008 when CAN officially ends.

Duane doesn't think that many of our students will use this transfer pattern since we have better guarantees with San Diego State University. Duane will send his list of initial courses to see if the campuses can agree and submit in October.

8. Miramar's Transfer Guide project

Duane and Wendy Stewart are receiving funding to produce a transfer guide. The goal is for the guide to be produced in the fall of 2007, it will include GE patterns. The guide will be update it if funding continues.

9. Serviceman's Opportunity College

The S.O.C. is a consortium of Community Colleges in the U.S. who have agreed to help students that are serving in the military to obtain degrees. Miramar and City already belong to this consortium. Mesa will look into joining. Duane will e-mail book to Myra, Elizabeth and Juliette.
