Old Business

1. IGETC LOTE faculty review:

Duane suggested making the following change to the end of point #6:

“Satisfactorily complete a proficiency test administered by a community college, university or other college in a language other than English. The test must assess the student proficiency at a level equivalent to at least two years of high school language. ~~The San Diego Community College District does not offer a test meeting this requirement.~~ The San Diego Community College District does not administer this test.”

Add the following language to the existing language for point #9:

Only students who have no other means to verify foreign language proficiency may pursue this option. Students must petition for faculty member verification through the Evaluations Office.

2. AP Chart revisions due to new IGETC standards:

Because of the new IGETC standards approved by UC, there are a few changes we need to make to reflect the new policy in our catalog:

- a) Replace the information in the IGETC Certification column with the information in the new IGETC guidelines and verify the CSUGE Certification information.
- b) Add the following exams:

- c) Under “Service Members Opportunity College and SOCNAV/SOCMAR”, make the following changes:

Replace SDCCD with San Diego City and Miramar Colleges throughout the entire SOCNAV/SOCMAR section.

Pending approval by Ron Manzoni, remove the following sentence: “The San Diego Community Colleges are members of the Interdisciplinary Studies and Criminal Justice SOCNAV/SOCMAR Networks.”

IB

Because a score of 5, 6 or 7 also clears 6 units of IGETC area 4B, add a second row under Economics and add the score of 5-7 in the appropriate column and modify the second note under the chart to reflect this: “**Except as noted**, IB tests can not be used to clear CSUGE or IGETC certification. See a counselor.”

CLEP:

Principles of Accounting was discontinued from CLEP, add in parenthesis “Discontinued 07-08”

Add Financial Accounting, score of 50 and 4 credits granted with elective credit for SDCCD

Change the scores of the following tests:

French level II 52 to 62

Spanish level II to 54 to 63

Remove the “Credit Granted for CSU” column

Modify the statement under the CLEP chart to: “CLEP tests can not be used to clear CSUGE or IGETC certification. See a counselor.”

DANTES:

Remove the “Credit Granted for CSU” column

Modify the statement under the chart to: “DANTES tests can not be used to clear CSUGE or IGETC certification. See a counselor.”

3. Catalog changes due to new IGETC standards:

Under the IGETC pattern, make the following changes:

Remove bullet #3 because is no longer a valid statement

For bullet # 4 replace “Students must apply for IGETC...” with “Students **should** apply for IGETC...”

New Business

4. SDSU Articulation Renewal Packet:

Every year SDSU sends an articulation renewal packet to Instructional Services, Articulation Officers agreed that our office doesn't need to send the packet back to SDSU since they receive the same packet.

Michelle will send the Articulation Officers the Approved Curriculum Changes Report in a word format.

5. Northcentral University MOU:

Duane is working with North Central to establish an articulation agreement and since he has been in contact with North Central, he asked if can represent all 3 colleges.

Libby said that she is ok with Duane taking the lead but that she will like to be included in the process. Duane said he can fill out the agreement and add at the bottom of the document a space for signatures for Juliette and Libby.

6. USC/BIOL 107:

Libby has been in contact with David Van Dyke at USC because Biology 107 has been removed from the USC core Category III articulation agreement. On his e-mail to Libby, David explained that USC cannot give GE III to on-line lab courses and because the way their computer system works they don't have a way to differentiate between the BIOL 107 offered at City and Mesa, which is a face to face course and the BIOL 107 offered at Miramar, which has an on-line lab component.

Libby is in contact with David to find a different way to represent this in the articulation agreement. Duane suggested making more prominent in the agreement that City and Mesa courses will always be accepted. He also suggested giving this information to the college Counselors.

7. Title 5 practices used for articulation of courses between California Community colleges and high schools:

Libby received a request from Mara Palma-Sanft for information on articulation between California community colleges and high schools. Libby is not clear on the request; Shelly will follow up with Lynne for clarification.

8. Italian, Chinese and Japanese AP Exam:

Libby will take the AP exams to the Department Chair and will get back to Articulation Officers and Shelly.

9. UCOP subject area review:

Dawn Sheibani sent an e-mail in regards to California Teach program, CaT-1 and CaT-2. The program includes field experience and seminar in Teaching Practice and Student Learning in Science and Mathematics; these courses are similar to Education 203 or a combination of Education 200 and 203.

10. UCTCA – Catalog discrepancy list:

Michelle will follow up with Dawn Sheibani on how to make changes to the ASSIST/IGETC comments.

Item will be added to the September DAC agenda.

11. IGETC acceptance of Upper Division course work:

The Articulation Officers felt that the evaluators would be the appropriate people to apply the IGETC rules for the use of upper division coursework to clear IGETC requirements.

12. Credit for Military Schools:

Add item to the November DAC agenda.

14. Additional agenda items:

Duane created a sheet to help explain the GE pattern options to the Academic Senate at his campus. He will forward the document to Articulation Officers and Shelly.

Since City College was denied approval for CSUGE BIOL 135 area E, Articulation Officers agreed to request Miramar's removal from CSUGE area E, effective fall 2008.

Since Miramar was denied for CSUGE PSYC 155 area E, articulation officers agreed to request removal of area E for all campuses.
