Waterborne Security Boat (WBS) Instructor Opportunities

San Diego City College – Military Education Program is seeking qualified applicants for the position of Waterborne Security Boat Instructors. This is a categorically funded program hence the position is contingent on award of a contract for instructional services with the Department of Navy, Center for Security Forces (CENSECFOR) in the Virginia Beach, VA vicinity.

Minimum Instructor Qualification

Have one (or more) of the following qualifications:

- Navy NEC 9502 (Instructor), or
- Navy NEC 9518 (Naval Leadership Development Program (NAVLEAD) Instructor, or
- Graduate of one of the following courses of instruction:
 Instructional Delivery Continuum (IDC) Journeyman Instructor Training (JIT) (A-012-0077); Instructional Delivery Continuum (IDC) Journeyman Instructor Training (JIT) Mobile Training Team (A-012-1011); Naval Leadership Facilitator (P-012-0045); Facilitator Training Course (P-012-0075); Nuclear Instruction Qualifications (NNPS) (A-661-0109) or
- Completion of an approved civilian (or commercial) formal course of instruction certified and evaluated as equivalent

Minimum Waterborne Security Boat Instructor Experience:

- Possess a minimum of three (3) years documented operational security boat experience serving in a Navy Harbor Security Maritime Detachment, USMC Small Craft Company; U.S. Navy Coastal Riverine Forces (CRF) Detachment; U.S. Navy Special Warfare Combatant Crewman (SWCC).
- Proficiency and skill sets to safely plan and deliver group-paced instruction on security boat tactics, techniques, and
 procedures in both a classroom setting and during underway training evolutions utilizing Safety/Operational Risk
 Management, Classroom Teaching Fundamentals, Training Requirements and Training Plans, and Training Scenario
 Scripting.
- Possess a minimum of three (3) years documented tactical and leadership experience in a Maritime Environment, proficient in the operation, maintenance, employment of Navy Force Protection boats, and be proficient in the following areas:
 - 1. Coxswain skills
 - 2. Maritime navigation
 - 3. In depth understanding of tactical small boat operations
 - 4. Craft systems and sub-systems
 - 5. Experience with logistical movement of small craft and associated gear
 - Tactical operations planning experience using a military decision-making process; organizational and individual
 planning; patrol coordination; development and issuance of a concept of operations, warning, and patrol; and
 mission debriefing

Additional Desired Qualifications or Certifications:

- Crew Served Weapons Instructor (CSWI) course completion
- Crew Served Weapons Operations and Maintenance (CSW O&M) course completion
- Range Safety Officer (RSO) certification
- American Heart Association Basic First Aid/CPR/AED certification

• Current Virginia and North Carolina certification as an Emergency Medical Technician (Basic)

Only U.S. Citizens are eligible and candidates are required to pass a National Agency Check with Local NACLC (or equivalent).
