#### **CTE Transitions Credit by Exam**

A form of early college credit, CTE Transitions Credit by Exam provides career education high school students and career education students at San Diego Continuing Education the opportunity to accelerate their college certificate and degree completion goals.

Students must be enrolled in a course tied to an active CTE Transitions Credit by Exam Agreement, receive a "B" or "A" in the course and on the final exam, and meet all additional agreement requirements.

#### 2020-2021 Active CTE Transitions Credit by Exam Agreements

- 23 San Diego Unified School District courses are tied to 18 college courses
- 48 San Diego Continuing Education courses are tied to 37 college courses

CTE Transitions Credit by Exam agreements are faculty led and begin with the exploration of course alignment.



#### High School Early College Credit Opportunities




