# CTE Transitions Credit by Exam DAC Update April 2023

## **Agreement Development**

Discussions are underway for the following agreements:

- City:
  - CISC 179 with E3Civic (charter) Per March DAC meeting discussion;
     City College AO advising not to move forward.
    - Final confirmation needed from Faculty
    - E3Civic has been notified that there are concerns and the request is being explored more closely.
    - E3Civic to be notified that this agreement will not move forward
  - INWT and SDCCE's courses SDCCE and City College met recently to review and discuss existing agreements and explore revised final assessments.
    - Changes are still in discussion for INWT 100. Final confirmation will occur soon and inform renewals effective for fall 2023.
    - INWT 120 and INWT 140 renewals have been approved with changes for 2023 2025 academic years.
  - CHIL 291 A-D (City and SDCCE) course alignment confirmed; all three credit colleges confirmed courses for CBE approval;
    - Waiting on confirmation of curriculum/CBE approval process/status
    - Goal is to get agreement in place for fall 2023
    - Faculty may choose to use portfolio for the final assessment, but the transcript will remain CBE (credit by exam)

### Mesa:

- Child Development and San Diego County Office of Education (SDCOE).
   Mesa College faculty exploring potential partnership with SDCOE. SDCOE sharing courses for Mesa faculty to review.
  - No changes since March update.
  - College courses TBD.
- MULT 123 (SDUSD and Mesa) SDUSD would like to explore agreement development with their Video Production 1,2 curriculum to Mesa's MULT 123.
  - There is an existing MULT 123 agreement with SDCCE
  - Mesa faculty have been contacted to review alignment
- o Revised noncredit Front-End Web Development (FEWD) agreement.
  - No change since March Update

#### **Process Revisions**

**SDCCE Credit by Exam Process Updates** – Updates to SDCCE's internal processes are complete.

- Opt in model in effect (as of Fall 2022)
- Noncredit courses tied to active agreements identified within the online schedule
- Final assessment grades will be entered into campus solutions
- Process changes summary
- Addition information available on the districtwide resource page

### **Overall Course Grade Eligibility**

In alignment with the SDUSD/SDCCD Joint Board Goals, the Vice Chancellor for Educational Services and Vice Presidents of Instruction at City, Mesa, and Miramar have approved a change to the overall course grade eligibility requirements for CTE Transitions high school to college and noncredit to college articulation credit by exam effective fall 2023.

- Beginning Fall 2023, the overall course grade eligibility requirement for Articulation Credit by Exam will be a C- or higher
  - This change does not impact any existing formal SDCCD Policy or Administrative Procedure nor does it impact the overall process of CTE Transitions Credit by Exam, agreements, or faculty activities tied to the

- agreements.
- Updating the overall course grade requirement to C- or higher will bring CTE Transitions Credit by Exam course grade eligibility into alignment with other districtwide course success metrics.
- This change will also align CTE Transitions course success with our high school partners' course success measures (C- or higher is both the SDCCD course success measure (across all four colleges) and K12's course success measure).
- No change to course-to-course alignment CTE Transitions Articulation
   Credit by Exam will continue to require course-to -course alignment (no change).
   Alignment will continue to be confirmed by college faculty and confirmed via the signed agreement.
- No change to End of Course Grade Eligibility End of Course (EOC) grade eligibility will remain unchanged. EOC grade eligibility requires the student to receive a B or higher on the college faculty approved final exam/assessment (no change).
- No change to the grade that is transcribed the grade transcribed to the college transcript will remain the end of course (EOC) grade which will remain B or higher (no change).
