- SDUSD to City
 - City's RTVF 146 course is being deactivated Fall 2024. This course has an active agreement with SDUSD's Broadcast Journalism 1,2 and Broadcast Journalism 3,4 course.
 - City faculty would like to articulate SDUSD's courses with FJMP 131.
 - DAC to discuss during 12/6 meeting
 - If faculty confirms the agreement, FJMP 131 may be treated like a renumbering and it added to the CRC/CIC agenda for CPL/CBE approval.
 - Clarity needed as to whether or not faculty will need to submit for CBE approval or if this can be automatically assigned based on prior course having it.
- Noncredit to City
 - INWT 100 No substantive changes since Nov 2023 update

- Course alignment and final assessments are being reviewed to reactivate the agreement between SDCCE and City College. Materials are currently being reviewed by City College faculty.
 - SDCCE Dean and Vice President expressed priority focus on this agreement
 - Meeting being scheduled for early Spring
