# Agreement Management Updates

#### Renewals

All renewals (active agreements expiring June or August 2022) for high school to college and noncredit to college have been approved.

Since the April update, the following final two renewals were confirmed:

- CHIL 176 (noncredit to credit)
  - City Faculty confirmed they would like to be added back into the agreement
  - Mesa Faculty confirmed approval for renewal
  - Miramar Faculty confirmed approval for renewal
- FIPT 101 (high school to Miramar)
  - Held an onsite visit at the high school. Faculty confirmed approval for renewal

#### Amendments for Year Two of Active Agreements

Noncredit to College – In April, we reported that an amendment for the noncredit to Mesa college web development agreement would be distributed to address the changes in course numbers on the noncredit side (no substantial changes - no change to curriculum, alignment, or approved final assessment). However, since our April report, we learned that the changes are, in fact, substantial and an entirely new agreement will be needed. An amendment will still be distributed – to confirm the end of the current agreement (early expiration). Details on the new agreement are noted below under "new agreement development."

#### New Agreement Development

Mesa College Web Development - SDCCE and Credit Faculty (Mesa) have been working to revise Front End Web Development (FEWD) agreement including a complete overhaul of course alignment and final assessments. Final exams are being collected and the revised agreement will be distributed for signatures prior to the end of the spring semester. Revised course mapping approved by credit college faculty can be found on page 3 of this update.

Discussions are underway for the following college courses for possible new agreements:

- FIPT 100 D (new since April report)
- BIOL 132 (new since April report)
- PHOT 180 and PHOT 181 (SDCCE and City) final assessments have been confirmed; agreement will be distributed for signatures
- AUTO 153 (Miramar and SDUSD) discussions still underway
- FASH 130 (Mesa and re-entry adult education program) discussions still underway
- MATH 119 (Mesa and SDUSD) discussions still underway

#### Catalog Updates

Credit college catalog updates were submitted. We are working on blue lines now. Noncredit College Catalog edits are underway.

## **Process Refinement**

**Noncredit to College Credit by Exam Process Updates -** SDCCE is making improvements to their internal processes tied to credit by exam. These process updates have been in the works for the past year, led by a district and SDCCE team. Process updates have been informed by students, faculty, and administrators, and have been vetted and approved by the Vice Chancellor and SDCCE's Vice Presidents of Student Services and Instructional Services.

Pending process updates:

- Promotion of Credit Opportunities Staring with the fall 2022 noncredit online schedule, all courses tied to active agreements will be identified with an icon to promote the college credit opportunities the course provides.
- Opt-in Model Starting with fall 2022 registration, noncredit students enrolling in noncredit courses tied to active agreements will be informed that their enrollment enables them to receive college credit if they meet the requirements (course and final assessment grade requirements and college application) and given a chance to opt-out of receiving the credit. Opt out requests will be monitored and, if they end up meeting the course and final assessment requirements anyway, SDCCE student services will reach out to them to double check if they want the credit.
- Final Assessment Grade Roster Starting with the fall 2022 semester, noncredit faculty teaching noncredit courses tied to active agreements will record the final assessment grades in campus solutions. We will end the use of our external electronic form.
