- 2.0 AB 19 and the San Diego Promise
- Future Direction

The Council discussed AB19 – The California Promise and the alignment with the San Diego Promise. It was reported that there are a number of unknowns about the specifics of AB19; however, the State Chancellor has confirmed that it will be funded. The State will be providing implementing guidelines. In the meantime, the Cabinet has been discussing preliminary plans for the San Diego Promise providing support for full-time students in their second year. Outreach will begin general information in the high schools in December, focusing on free college for full-time students. Once the state issues implementing guidelines, the District will finalize plans for San Diego Promise. The Promise Coordinators will be meeting later this month to coordinate outreach. In the meantime, the outreach teams should plan to proceed with outreach to the high schools as planned.

3.0 AB 705 – Assessment

- Future Direction

The Council was provided with a summary of AB 705 which modifies the Matriculation Act to ensure colleges maximize the probability that students complete college level (not transfer bound) or transfer level (transfer bound) English and math courses within one year. In addition, the plans for the State Common Assessment have been discontinued. There has been a Districtwide Assessment Workshop that has been meeting for the past couple years to plan for MMAP and Common Assessment. The group is being reconstituted to include the Vice Presidents and will begin to plan for the future of assessment in the District. The first meeting will be in December. The Council was supportive of the direction. Given the size of the group, it was recommended that there be an option for teleconferencing.

4.0 DACA Student Academic Forgiveness – Update

The Council was provided a brief update on the Academic Forgiveness Plan; approximately 25 DACA students petitioned by the deadline districtwide.

5.0 Campus Solution Counseling Training Plan – Revisited

The Council discussed the timeline for training the Counselors in Campus Solutions. It was agreed that 20 hours of in person training would be conducted, in load, and another 20 hours would be completed independently online (as needed) not in load, the following dates have been tentatively agreed to:
