2.0 Campus Solutions Update

- Go-Live Plan
- Communication to Students
- Training Update
 - The Council reviewed the Campus Solutions Summer 2019 transition timeline plan and draft publication that will be included in the 2019 summer class schedule and posted on campus.
 - Stephanie Crosby, Continuing Education AS Dean, agreed to make the document 508 compliant.
 - The Council was also provided an update on the upcoming training schedule and urged to ensure current users attend a session or they will not be granted access to the system. In addition, attendees must sign-up in advance so they will have access to the training system and materials.

- 3.0 Lactation Services Follow-Up
 - AB 2785
 - The Council reviewed the updated language for the student and faculty websites. Updates include the locations and room numbers of the lactation areas on each college campus
 - It was reported the DSPS faculty are reviewing the internal guidelines and will provide feedback to the Vice Presidents.
- 4.0 Disclosure of New Non-Resident Tuition Exemption
 - AB 2210
 - The Council discussed the new requirement to disclose non-resident tuition exemptions for special immigrant visa holders and refugee students in accordance with AB 2210.
 - The Council reviewed the language that has been posted on Student Web Services with information to students and the public.
- 5.0 AP 3200: Associated Students Organizations and Guidelines for Student Clubs and Organizations Revisited
 - The Council revisited proposed changes to AP 3200 which included the following updates:
 - Limiting terms of service to two terms at the executive officer level.
 - Prohibiting the use of unauthorized spaces during non-office hours or without proper supervision.
 - The Associated Students requested clarification regarding non-business hours versus non-office hours for use of unauthorized spaces.
 - The Council recommended changing non-business hours to non-office hours.
 - The Associated Students recommended changing the language that states "two years" at the executive officer level, to "two terms".
 - The Council approved the final changes to AP 3200.
