#### **DEFINITION**

Under the direction of the Manager, Network and PC Services, or assigned manager, perform a wide variety of highly specialized technical and supervisory tasks to support the design, development, analysis, testing, modification, installation, configuration, and maintenance of computer systems and programs related to wide area networking, including hardware and software. Positions in this classification directly support core network infrastructure subsystems to ensure all networks and Internet related services are available to all district sites.

Positions in this classification provide districtwide support of multiple core infrastructure subsystems that service all campus computing needs, including administrative, instructional, and contract education environments. This position supervises Enterprise Network Specialists and may act as a lead and coordinate work teams comprising Microcomputer Specialists and campus-based Network Specialists, requiring a variety of areas of technical expertise.

## **DISTINGUISHING CHARACTERISTICS**

The Enterprise Network Specialist classification is distinguished from the campus or Continuing Education site based Network Specialist classification in that positions assigned to this classification provide districtwide support of wide area networks and Internet specific equipment and services. Incumbents work independently and demonstrate independent decision making ability where no technical precedence may exist to keep the District network infrastructure operational. This position may lead teams of campus Microcomputer Specialists and campus-based Network Specialists in the design and installation of major network infrastructure projects.

## **EXAMPLE OF DUTIES**

- 1. Perform highly specialized technical tasks in support of the design, development, analysis, testing, modification, configuration, installation, and maintenance of computer programs and systems related to the wide area network, including hardware and software.
- 2. Plan, organize, and direct the work of the Enterprise Network Specialists, evaluate and document performance, and recommend disciplinary action when necessary; review staff work for accuracy and timely completion of assigned duties. Train staff in new and existing procedures; develop work schedules.
- 3. Demonstrate initiative and independent judgment in creating technical procedures related to District network infrastructure.
- 4. Install, upgrade, and manage network infrastructure subsystems, such as Exchange email, Internet email, DNS, Active Directory, LDAP, DHCP, firewall, Web services, and authentication.
- 5. Communicate with campus Network Specialists and Help Desk staff for any system outages and coordinate all service downtimes according to Information Technology Department policies and procedures.
- 6. Maintain server operating system patches and updates to ensure a secure computing environment, including anti-virus, anti-spyware, and anti-spam updates.
- 7. Monitor subsystems as specified and respond to automated messages and Help Desk calls regarding core infrastructure subsystems.

- 8. Proactively maintain and monitor all web servers; perform preventive maintenance on all server and networking hardware as specified by the manufacturers' and department procedures.
- 9. Coordinate upgrade activities with all appropriate personnel and end-user departments.
- 10. Train and assist coworkers, faculty, staff, and students in the use of network services.
- 11. Coordinate with Help Desk Services to identify trends in support of computer or network related equipment or services to better meet the needs of faculty and staff.
- 12. Perform related duties as assigned.
