2.0 Priority Registration Update

- The Council was provided with a draft outreach plan 2013-2014 for final review.
- The Council agreed and approved the outreach plan timeline.
- The Council reviewed the three draft email notices for Group 1a. These are students that have a degree/transferred goal; 60-90 units (with skill levels and no education plan and without skill levels and no education plan; transcripts on file (evaluated and non-evaluated).
- The Council made minor changes to the draft email notices and will be sent out to students by next week.
- The Council also requested a data update on the identified students in this outreach group. Liane DeMeo will send the updated data and the student names to the Vice Presidents Student Services.

- Ailene Crakes inquired if there is an automatic way for transcripts to be evaluated to expedite the process for Counseling. It was discussed that our current processing system does not have that capability and will be a future consideration with the new system.
- The Council also requested that the Request for Transcript Evaluation form be fillable. Gail Conrad will report back at the next meeting
- The Council was provided with a draft priority registration email alert for fall 2014 for all students. The email alert includes the details of new registration priority system that will be in place in the beginning fall 2014.
- The Council made minor changes and the email will be sent out to students at the end of September.
- The Council was provided with a draft campus poster on important priority registration information. It was agreed to increase the size of the poster and minor edits were made. The Council will review the draft poster at a future meeting.
