5.0 Board of Governors Fee Waiver Program Timeline

 The Council was informed that the California State Chancellor's office extended the Board of Governors (BOG) Fee Waiver program implementation date from fall 2015 to fall 2016. It was agreed to revise any advertisement on the web or on campus stating previous information.

6.0 Military Dependent Email

- State regulations require that California Community College Districts gather additional information from students who are military dependents for reporting and funding purposes. The Council was provided with an email that will be sent to students requiring information needed by military dependents.
- The email will be sent to students on November 17, 2013.

7.0 High School Concurrent/Dual Enrollment Proposal

 The Council discussed the state's proposed high school concurrent/dual enrollment proposal. It was agreed to reevaluate and support San Diego Community College District (SDCCD) partnerships with San Diego Unified School District (SDUSD) as a priority and postpone concurrent/dual enrollment.

- The Council was reminded that SDCCD and SDUSD have been meeting monthly this year and partnerships are still under discussion.
- Gail Conrad will draft a recommendation and report back at a future Student Services Council meeting. It was agreed to present the final recommendation at a future Chancellor's Cabinet in January 2014.

- The Council was provided with a draft of AP 3100.2 *Student Disciplinary Procedures* that reflects changes from the Student Affairs deans.
- The Council agreed to finalize the procedure. It will be posted on the district student services website.
