- 1.0 Approval of Minutes
  - September 3, 2015
  - Approved
- 2.0 MMAP Schedule and Plan Spring 2016
  - At the September 3, 2015, Student Services Council meeting, the Council reviewed *Common Assessment Initiative: Multiple Measures Assessment Project (MMAP)* Pilot Evaluation plan for 2015-2016. It was agreed to review the timeline for spring 2016 and assessment plan at this meeting.
  - The Council reviewed the MMAP cohort placement procedures and timeline for spring and fall of 2016.
  - The Council had concerns regarding the proposed deadline dates for spring 2016 since they were Thanksgiving break. It was agreed to adjust the timeline.
  - The Council agreed to send out a preliminary email notification to students on their revised assessment and placement.

## 3.0 AP 3100.2 Student Disciplinary Procedures (DRAFT)

- The Council was provided with draft administrative procedure AP 3100.2 *Student Disciplinary Procedures* incorporating a change in composition of the descriptive committees for cases involving sexual assault.
- The Council agreed that the draft procedure would go forward to the next Chancellor's Cabinet meeting District Governance Council meeting.
- 4.0 Student Services Council Annual Assessment Review and Discussion
  - It was agreed to review and discuss the participatory governance survey details at the next meeting.
- 5.0 Fall Counselor Workshop Debriefing
  - The Council debriefed and provided feedback on the fall counselor workshop that was held on Friday, September 25<sup>th</sup>, at this meeting.
  - The Council thanked Miramar College for hosting and providing the food and refreshments.
  - It was proposed to have a full-day counselor workshop and it was agreed to discuss this at a future meeting.
