

	 150 REPORT ON COMMUNICATIONS/STATEWIDE & LEGISLATIVE ISSUES Chancellor Carroll Chancellor Constance Carroll reported that the state's fiscal situation continues to deteriorate. She noted that the current-year California budget is still out of balance and that a 1.2% "deficit factor" was being applied to community college apportionment, which means an additional reduction of \$2.4 million for the SDCCD. She noted that the Legislative Analyst's Office (LAO) projected an additional state deficit of \$7.8 to \$12 billion in 2009-2010 due to continuing property tax shortfalls and rising unemployment. Chancellor Carroll also reported that the portfolios of the two retirement agencies, PERS and STRS had declined and a 2% to 4% contribution increase might be assessed in July 2010. Last, she indicated that the propositions on the May Ballot, totaling \$5.8 billion in the state's budget proposal were running behind in current polls. If these propositions fail, the state budget deficit will increase and further reductions will follow. While the SDCCD is keeping to its plan of preserving core programs and protecting contract employees, this situation requires continuing
