11. Report on Communications/Statewide & Legislative Issues

11.01 Chancellor Constance M. Carroll

Chancellor Constance Carroll reported on two important legislative bills, AB 97 and SB 103, which are each intended to backfill the current \$100 million deficit in the California Community Colleges budget. The deficit was caused by the fact that projected revenue from the dissolution of the state's redevelopment agencies has not materialized. Dr. Carroll said that all districts in the state, including the SDCCD, are encouraging calls to legislators urging their support.

12. Report of the Trustees

12.01 Student Trustee Carolina Moreno

Student Trustee Carolina Moreno reported that the United Student Council met last week to discuss increasing the amount of interaction and collaboration between the Colleges' Associated Student Governments and that of Continuing Education. In anticipation of Constitution Day on September 17, 2013, the Associated Student Governments are planning activities, including staffing voter registration tables and passing out copies of the United States Constitution.

12.02 Trustee Mary Graham

Trustee Mary Graham reported that the Board's Accreditation and Student Learning Outcomes subcommittee met and reviewed the 2012-2013 Factbooks for the District, each college, and Continuing Education. The Subcommittee also discussed student completion statistics and the institution's Mid-Term Accreditation Reports (to be approved later in the meeting). She praised the colleges and Continuing Education for all of their hard work on these reports.

12.03 Trustee Maria Nieto Senour

Trustee Maria Nieto Senour echoed Trustee Graham's praise for the Mid-Term Accreditation Reports. She reported that she also attended the Board Study Budget and Audit subcommittee meeting to review the 2013-14 Adopted Budget, which the Board will consider later in the meeting.

12.04 Trustee Bernie Rhinerson

Trustee Bernie Rhinerson reported that he attended and enjoyed two recent building events at Miramar College: the Student Services Center Building Grand Opening and the Fire Science and EMT Building groundbreaking. He noted that Miramar College continues to evolve in a positive way. He also discussed his attendance at the Continuing Education convocation, where he enjoyed the presentations. Trustee Rhinerson is looking forward to similar events next year. Finally, he noted his attendance at a First Friday lecture at Mesa College featuring a professor from Stanford University, who spoke about technology and learning environments. He was impressed with the event's turnout and content, and looks forward to similar events in the future.

President Rich Grosch also reported on his attendance at the Continuing Education Convocation, noting it was a great event. He thanked Executive Vice Chancellor Bonnie Dowd for her presentation to the Board Budget Study and Audit subcommittee regarding the Adopted Budget that will be considered by the Board later in this meeting. Additionally, he discussed his attendance at the Miramar College Student Services Building grand opening and the moving and memorable Fire Science and EMT building groundbreaking, noting the transformative impact the Bond measures are having. He commended the Propositions S and N Citizen's Oversight Committee for their role in encouraging the District to accelerate its building program during the recession, which gave the District great value for its money and added jobs during a difficult time. Finally, he commented on a wonderful presentation at the recent SDICCCA meeting, given by Chancellor Carroll on baccalaureate degree efforts.

13. Report of the Chancellor

13.01 Chancellor Constance M. Carroll

Chancellor Carroll indicated that the statewide Community College Baccalaureate Degree Study Group has started to meet and hopes to have preliminary recommendations to share with the field in late November. The group is made up of 16 people from throughout the community college system, as well as representatives from the UC and CSU systems. Legislation would be required to change the mission of the community college to allow such a change; most other states have required 2-3 years of discussion before legislation has passed. Dr. Carroll also informed the Board that student enrollment is up, and the District is projecting a 1.4% increase in full-time-equivalent students (FTES).

Under California Law, the 2013-2014 fiscal year budget may not be finally adopted by the Board of Trustees until after this public hearing has been held.

President Grosch opened the Public Hearing. No speakers came forward. President Grosch closed the Public Hearing.

15.02 490 - Consideration and approval of the 2013-14 District Adopted Budget.

The Board heard comments by Chancellor Constance Carroll and a presentation by Executive Vice Chancellor Bonnie Dowd. The total budget is \$865,675,134, including \$304,305,515 in General Fund Unrestricted and Restricted operational funds. The balance of \$561,369,619 consists of the current issuances of Propositions S and N bond funds, as well as federal and special funds. The Board Budget Study and Audit Subcommittee (Grosch and Senour) reviewed the budget prior to its presentation to the Board. This approval meets the state's legal filing deadline of September 15 for community colleges.
