A. NAME OF AGENDA ITEM

Public Comment, Second Review and Selection of Trustee Areas Based on 2010 Census Data and Drawn in Compliance with the California Voting Rights Act and Federal Voting Rights Act.

B. STATEMENT OF ISSUE/PURPOSE

1. Background and Purpose

On March 10, 2011, the District passed a Resolution entitled, "In the Matter of Initiating a study of the San Diego Community College District Election System to address alternatives to comply with the California and Federal Voting Rights Act." In furtherance of that resolution, the District has partnered with San Diego County Office of Education and a demographer, the National Demographics Corporation, to identify and move forward with the steps necessary and prudent to ensure the District's compliance with the California Voting Rights Act (CVRA) and the Federal Voting Rights Act (FVRA). In that regard, the demographer has drafted tentative trustee areas for review and public comment.

The tentative trustee areas were drafted in accordance with the redistricting criteria adopted by the Board of Trustees at the July 7, 2011, Board of Trustees meeting. The redistricting criteria are included as ATTACHMENT A.

The Current Trustee Areas are included as ATTACHMENT B.

The Options for Draft Trustee Areas are included as ATTACHMENT C.

The tentative trustee areas were presented, discussed and public input invited and taken at the Board of Trustees meeting on August 25, 2011.

2. Cost and Funding

There is no additional cost to the District.

C. PROPOSAL

The Board of Trustees reviews and takes public comment on the draft trustee areas and votes on and selects new trustee areas.

WHEREAS, the Board of Trustees of the San Diego Community College District ("District") passed a resolution, dated March 10, 2011, authorizing the review of its current trustee election system in light of the California Voting Rights Act to determine if any changes are required in the current system so as to comply with this Act; and

WHEREAS, in furtherance of the March 10, 2011, resolution, the Board of Trustees of the San Diego Community College District authorized the retention of a demographer and legal counsel to assist in the review of the current trustee election system; and

WHEREAS, as a result of the review of its current trustee areas, draft trustee areas were drawn and reviewed by the demographer and counsel in compliance the Federal Voting Rights Act and the California Voting Rights Act; and

WHEREAS, the draft trustee areas were reviewed by the Board of Trustees at regularly scheduled meetings on August 25, 2011, and September 8, 2011, and public comment was solicited and considered.

NOW, THEREFORE, BE IT RESOLVED as follows:

- (1) The Board determines that it is in the best interest of the District to adopt draft trustee area PLAN 2; and
- (2) The Chancellor is directed to notify the San Diego County Committee on School District Organization and the San Diego County Registrar of Voters of its adoption of the trustee areas mentioned above:



REDISTRICTING CRITERIA


Adopted by the Board of Trustees on July 7, 2011

Legal Requirements:

- Each district shall contain nearly equal numbers of inhabitants as required by the U.S. Constitution;
- District borders shall be drawn in a manner that complies with Section 2 and Section 5 of the Federal Voting Rights Act;

Traditional:

- Each district shall consist of compact, contiguous territory as much as possible;
- Each district shall respect communities of interest as much as possible;
- District borders shall follow visible natural and man-made geographical and topographical features as much as possible;
- District borders shall be drawn to avoid locating more than one current trustee in any one district as much as possible;
- Each new district shall preserve the corresponding existing district's population and territory as much as possible;
- Districts known to be areas of higher-than-average population growth in the two to five years following redistricting may be under populated within the population deviation amounts allowed by law.
