The property line fencing between Harry West Gym and SR-163 is damaged and parts non-existent causing security and liability issues required to be addressed through landscape cleanup and greenhouse demo. The damaged fence that separates the freeway and secures the gym allows pedestrians to enter the property, camp over night, causing an unsafe environment for students and staff.

#### **Look Ahead**

Three additional contractors have completed job walks and submitted their proposals. A Fence Proposal Comparison has been prepared, identifying Scott Fence as the apparent low bidder. Scott Fence has also provided cost estimates. Awaiting direction from City College regarding the existing greenhouse structure. Additionally, SDCCD is reviewing the iron fence proposals. Cumming Group is collaborating with One Tripp Tree on their proposal, which includes options for improving the area after clearance. Potential weed mitigation and landscaping strategies, such as using land-scape fabric and wood chips to enhance aesthetics to be reviewed.
