DEFINITION

Under the general supervision of the Facilities Manager, plan, organize, implement, direct and oversee a variety of District maintenance and repair activities and supervise skilled workers in the completion of maintenance and repair of District buildings and grounds.

EXAMPLE OF DUTIES

- 1. Supervise assigned employees; provide leadership and training as needed including awareness and safe handling of hazardous materials; appraise performance; provide for technical direction and guidance; make employment and transfer recommendations; may perform trade skills.
- 2. Schedule, plan, implement, and organize District skilled trade construction and maintenance projects.
- 3. Monitor the disbursements for a medium to large budget; prepare reports to management.
- 4. Coordinate with other maintenance supervisors and Facilities department management and staff regarding projects.
- 5. Work with outside contractors as needed. Write specifications, find and solicit bids from contractors, award bids, may inspect contractor work, and assure that the contractors meet schedules.
- 6. Assign routine and emergency maintenance jobs to skilled and semi-skilled trade workers, including rough and finish carpentry, glazing, roofing, masonry, painting, locksmith, electrical installation and repair of hardware and equipment.
- 7. Estimate cost of maintenance repair work; recommend use of outside vendors as appropriate; inspect completed work to assure compliance with contract requirements.
- 8. Inspect the work of skilled trade workers.
- 9. Inspect District buildings, grounds, and equipment for needed repair and maintenance; schedule preventative maintenance. May specify, direct, and inspect construction work, assuring projects meet Code and completed on time and on budget.
- 10. Prepare and submit budget for assigned functions; review periodic budget reports to compare actuals against the forecasts; provide explanations of variances as necessary.
- 11. Prepare various reports for submission to superiors; accumulate data and prepare narrative explanations.
- 12. Perform related duties as assigned.
