

ADMINISTRATION OF JUSTICE (ADJU)

***340 P.O.S.T. Certified Cultural Diversity Training**

**8 hours (total), 0.5 unit
Grade Only**

Offered at Miramar.

Prerequisite: Administration of Justice 381, 382, 383, and 384, each with a grade of "C" or better, or equivalent.

Deactivate at Miramar effective 022. ***Approved***

This course provides training for peace officers in the area of community and cultural interaction. The course focus is on principles that hold promise for moving California Law Enforcement to a higher level of understanding, acceptance, and appreciation for our diversity.

***341 Tactical Training for Supervisors**

**16 hours lecture (total)
24 hours lab (total), 1.5 units
Grade Only**

Offered at Miramar.

Prerequisite: Administration of Justice 381, 382, 383, and 384, each with a grade of "C" or better, or equivalent.

Deactivate at Miramar effective 022. ***Approved***

An intense 40 hour course designed to provide updated supervision training in the areas of Officer Safety/Field Tactics, Officer Involved Shootings and Advanced Patrol Procedures for members of Law enforcement Agencies currently assigned to supervise patrol duties.

***342 Advanced Investigative Techniques**

**24 hours lecture (total), 1.5 units
Grade Only**

Offered at Miramar.

Prerequisite: Administration of Justice 381, 382, 383, and 384, each with a grade of "C" or better, or equivalent.

Deactivate at Miramar effective 022. ***Approved***

This course is designed to enhance and upgrade the investigative skills of Law Enforcement personnel presently assigned to Detective positions. Emphasis will be on Care Management, Networking and Resources.

***347 Supervisory Leadership**

**8 hours lecture (total), 0.5 unit
Grade Only**

Offered at Miramar.

Prerequisite: Administration of Justice 381, 382, 383, and 384, each with a grade of "C" or better, or equivalent.

Deactivate at Miramar effective 022. ***Approved***

Instruction will be provided on how to supervise and lead law enforcement officers who are involved in problem solving.

***349 Sexual Harassment and Cultural Diversity in Law Enforcement**

**8 hours lecture (total), 0.5 unit
Grade Only**

Offered at Miramar.

Prerequisite: Administration of Justice 381, 382, 383, and 384, each with a grade of "C" or better, or equivalent.

Deactivate at Miramar effective 022. ***Approved***

The first segment of this course is designed to enlighten the law enforcement officer to the serious and detrimental nature of sexual harassment in the workplace. Focus is on prevention, recognition and reporting of such occurrences. Segment Two focuses on the professional and personal benefits of understanding cultural diversity, its history and demographics. Associate Degree Credit.

- *353 Livestock Handling for State Humane Officers** Offered at Miramar.
10 hours lecture (total)
30 hours lab (total), 1 unit Deactivate at Miramar
Grade Only effective 022. *Approved*
- This course is designed to instruct and prepare state humane officers in the proper methods of handling livestock and loading and unloading horse trailers with a special emphasis on restraint and weight condition scoring. (FT)
- *354 State Humane Officers Basic Training Academy** Offered at Miramar.
80 hours lecture (total), 5 units
Grade Only Deactivate at Miramar
effective 022. *Approved*
- A basic investigations course with emphasis on animal abuse crimes. This course gives a broad overview of animal abuse crimes and an in-depth discussion of investigatory procedures. Its goal is to provide Animal Control Officers and Humane Officers with a thorough understanding of how to investigate animal abuse. Associate Degree Credit.
- *356C Peace Officer Orientation II** Offered at Miramar.
46 hours lecture (total)
10 hours lab (total), 3 units Deactivate at Miramar
Grade Only effective 022. *Approved*
- This course meets the requirements of P.C. 832 which includes classes in Laws of Arrest, Search and Seizure, Ethics, Discretionary Decision Making, Dangerous Weapon Control Law, Arrest and Control Techniques, and Firearms. Completion of Administration of Justice 356C meets Peace Officer Standards and Training (P.O.S.T.) requirements for Level III Reserve status.
- *360 P.O.S.T. Certified Regional Reserve Academy** Offered at Miramar.
94 hours lecture (total)
390 hours lab (total), 14 units Deactivate at Miramar
Grade Only effective 022. *Approved*
- This course is not open to students with credit for Administration of Justice 356C, 357, or 358.
This course prepares the Reserve Officer to function in the field as a primary officer. Emphasis is on the 35 Learning Domains prescribed by P.O.S.T. Course exceeds the minimum peace officer training requirements of Section 832 of the California Penal Code. Completion of this course will waive the requirement of ADJU 101, 102, and 103. (FT)
- *364 State Humane Academy - Advanced** Offered at Miramar.
20 hours lecture (total)
20 hours lab (total), 1.5 units Deactivate at Miramar
Grade Only effective 022. *Approved*
- Prerequisite:* Administration of Justice 354 with a grade of "C" or better, or equivalent.
This is an advanced animal cruelty investigations course with emphasis on evidence collection and court preparation. Satisfactory completion of the Basic State Humane Academy is mandatory. Associate Degree Credit.

***370 P.O.S.T. Certified Regional Reserve Academy, Module D**

**112 hours lecture (total)
336 hours lab (total), 14 units
Grade Only**

Offered at Miramar.

Deactivate at Miramar effective 022. **Approved**

Prerequisite: Administration of Justice 360 with a grade of "C" or better, or equivalent, or successful completion of Modules A, B, and C of a P.O.S.T. certified reserve academy.

This course is designed for current Level 1 reserve peace officers. It meets the Level 1 reserve peace officer P.O.S.T. minimum standards of training and eligibility for full-time peace officer employment. Course work includes subjects such as new legislation and legal updates for 1997, special technical subjects addressing social issues and skill proficiency training in vehicle operations, firearms, chemical agents, defensive tactics, investigative report writing, traffic accident investigations, patrol techniques, and responding to crimes in progress. Associate Degree Credit. (FT)

ART-FINE ART (ARTF)

100 Art Orientation

3 hours, 3 units

Offered at City, Mesa, and Miramar.

A survey of the field of visual arts, including aesthetic approaches, philosophies, media, professional fields, regional and cultural contributions. Recommended for general education and Fine Arts majors. Illustrated lectures. (FT) Transfer Credit: CSU and/or private coll/ univ.; UC.

May be offered via distance education at Miramar effective 022. **Reviewed**

BUSINESS STUDIES (BUSE)

100 Introduction to Business

**3 hours, 3 units
Grade Only**

Offered at City, Mesa, and Miramar.

Advisory: English 50 and 55, or Business 92, each with a grade of "C" or better, or equivalent, or Assessment Skill Levels W4 and R4.

An elementary course for both business and non-business majors. Provides a broad understanding of the business community, its functions, terminology, occupational choices in the various fields of business and the place of business in the American economy as a whole. (FT) Transfer Credit: CSU and/or private coll/ univ.; UC.

May be offered via distance education at Miramar effective 022. **Reviewed**

COSMETOLOGY (COSM)

50 Rules, Regulations, and Physiology

**2.5 hours lecture, , 2.5 units
Grade Only**

Offered at City.

Corequisite: Cosmetology 50L; or 50LA and 50LB; or 60L; or 60LA and 60LB.

Advisory: Completion of or concurrent enrollment in English 51 and 56, each with a grade of "C" or better, or equivalent, or Assessment Skill Levels W5 and R5.

Limitation on Enrollment: This course is not open to students with credit for Cosmetology 111, 111A or 111B.

This is an introduction to the basic principles of anatomy and physiology, including bone structure, circulation, muscle and nerve components of the body as well as hair structure. This course incorporates bacteriology, sanitation, sterilization and cosmetology rules and regulations as required for licensure in the State of California. Emphasis is placed on consumer protection and health of the community as related to cosmetology services. (FT) Associate Degree Credit.

ECONOMICS (ECON)

Integrate course outline effective 024 ***Approved***

120 Principles of Economics I

**3 hours, 3 units
Grade Only**

Offered at City, Mesa, and Miramar.

Advisory: English 51 and 56, each with a grade of “C” or better, or equivalent, or Assessment Skill Levels W5 and R5.

May be offered via distance education at Miramar effective 022. ***Reviewed***

Introduction to basic economic principles and theory relating to problem analysis, structure of our institutions and the formation of public policies. Emphasis is placed on the broad overall performance (macro-analysis) of the economy with concentration in such areas as incomes, employment and output; economic stability and growth; fiscal and monetary policy. (FT) Transfer Credit: CSU and/or private coll/ univ.; UC. (CAN ECON 2)

PHILOSOPHY (PHIL)

103 Historical Introduction to Philosophy

3 hours, 3 units

Offered at Mesa.

Advisory: English 101 or 105 with a grade of “C” or better, or equivalent, or Assessment Skill Levels W6 and R6.

Change advisory effective 024. ***Approved***

This course provides an introductory study of the aims, methods, issues and problems associated with philosophy and philosophical activity from an historical perspective. Readings and discussions in the course emphasize a study of the philosophical endeavors of major philosophers in their historical contexts.

Change course description effective 024. ***Approved***

Materials for this survey of philosophical activity, orientations and view of philosophers may be drawn from classical and contemporary thinkers. Students are encouraged to articulate, analyze and compare their own beliefs/positions with historically significant philosophical theories. This course may be of interest to students pursuing studies in History and Humanities. (FT) Transfer Credit: CSU and/or private coll/univ.; UC.
