#### **I. OLD BUSINESS**

##### **A. Submission Process for SDCCD GE, IGETC, CSUGE, UCTCA**

The Articulation Officers agreed on a new procedure for the Yearly Review and Approval of GE/Transferability Actions Report that is submitted to CIC at the end of the year. The procedure is as follows: The Instructional Services office will bring to DAC the CIC summaries from the CIC meetings that were held prior to the DAC meeting and the Articulation Officers will identify the courses that need to be proposed for District GE, IGETC, CSUGE, UCTCA and Multicultural/American Institutions.

Libby suggested adding courses that are being proposed for Multicultural and American Institutions to the report.

Libby brought up DANC 111; the course needs to be proposed for UC. The course is not an activity course.

Paula had questions about GEOL 104, Laurie already responded to her via e-mail. Laurie e-mailed Paula the course outline and removed the UC transferability.
