Old Business

1. Statway Memo: Mara Palma-Sanft

Mara asked if a note can be added to the catalog to inform counselors and students Math 47A and Math 115 are a course sequence and to receive credit both courses need to be taken. Michelle will send the Articulation Officers a pdf of the language included in City's catalog.

2. PHIL 100: Mara Palma-Sanft

Miramar received a request to submit course outlines for PHIL 100 and 205; the UC is looking for explicit language demonstrating the courses meet the UC Area E transferability requirement, in addition, the UC is requesting a word count be added to the course outline for PHIL 205 but not 100; City and Mesa didn't receive the same request. Mara clarified with the UC and the request applies to all three campuses, their recommendation is to submit the course outlines during the UCTCA submission cycle in August. Articulation Officers will consult with faculty.

After consultation with faculty, the consensus from the Philosophy faculty at all three colleges is the PHIL 100 will stay as is, a word count is not necessary. For PHIL 205, a word count is already listed.

Articulation Officers will submit the course outlines during the UCTCA submission cycle.

New Business

3. CCCCCO TMC template: Shelly Hess

Mesa was asked to remove the completion of the American Institutions requirement language from the Spanish ADT. Juliette explained the language is standard language that has been added to other ADT degrees approved by the State Chancellor's Office. Juliette will follow up on this request.

4. IGETC for STEM catalog listing: Juliette Parker

After discussion, Articulation Officers recommended adding a statement to the catalog instead of developing and maintaining a separate IGETC for STEM list. Shelly will consult with Student Services.

5. C-ID Resolution for ASCCC: Juliette Parker

Juliette explained Mesa Academic Senate approved the C-ID resolution for the ASCCC. City and Miramar's Academic Senate are voting next week.

6. C-ID and the conditional approval of U.S. History courses: Juliette Parker
Articulation Officers agreed to submit an appeal on these courses to C-ID; Elizabeth will look at the courses and C-ID descriptor.

7. CCCC submission for UCTCA and transfer GE course approvals: Juliette Parker
Juliette offered to submit Mesa's courses to the State Chancellor's office if this would alleviate the issue with the double course submission for those courses proposed for UCTCA; Shelly will consult with Erica. Shelly explained that another solution would be for Articulation Officers to remind Instructional Services of those courses proposed for UCTCA, so once the approval has been received Instructional Services can update the transfer status (from CSU transferable only to UC transferable).

8. Inter-institutional agreement grid: Juliette Parker
Tabled for the 2015-2016 academic year.

9. SDSU Articulation Renewal: Elizabeth Norvell
Articulation Officers received the SDSU Articulation renewal request; Michelle will send the approved curriculum report to the AOs.
