This research agenda focuses primarily on the continuation of existing CTE reports and projects (listed above on page 1), and upcoming projects (listed above on page 2) as well as general commitments including:

- Incorporate disproportionate Impact analyses, and DI in CTE, wherever present
- Embedded researcher

- Support ongoing improvement
