#### **OVERVIEW**

This Fact Book is a publication of the SDCCD Office of Institutional Research and Planning for San Diego Continuing Education. It is designed to serve the information needs of the community with a primary focus on student enrollment, demographics, and outcomes.

The Fact Book is a rich source of Continuing Education trend information that may be used for planning and decision making. The book contains the following four sections:

- 1) Headcount and Student Characteristics. Provides information on student demographic characteristics (e.g., age, ethnicity, and residence by service area) over five years.
- 2) Student Completion (Awards Conferred). Provides information about certificates of completion, high school diplomas, and GEDs awarded. All of the information is provided in summary form, as well as by demographic characteristics of interest.
- 3) Productivity. Provides information on annual FTES and enrollment.
- 4) Human Resources. Provides information on the number of employees by employment type, ethnicity, and gender.

Each section contains the following benchmarks: 1) The percentage change over the five year period being reported, 2) The Continuing Education average, and 3) The "Districtwide" (includes Continuing Education) average.

## Section I Headcount and Student Characteristics

#### Continuing Education Fact Book 2018 \_

This section of the Fact Book contains student headcount by various student characteristics. The headcount figures are individual counts of students, or unduplicated headcount. Less than one attendance hour, never attends, cancelled, apprenticeship, contract, and fee only classes are excluded. The headcount information is reported over a period of three or five years to analyze trends and establish benchmarks. Headcount information is reported by the following segments:

- 1) Overall
- 2) Gender
- 3) Ethnicity
- 4) Age
- 5) Service Area of Residence
- 6) Income Level
- 7) Educational Objective
- 8) Primary Language
- 9) Prior Education Level
- 10) DSPS
- 11) Day, Evening, and Online Status

**Overall Headcount:** Unduplicated headcount for Continuing Education maintained relatively steady enrollment from Summer 2013 through Summer 2015, before declining in Summer 2016 and Summer 2017. After gains between Fall 2013 and Fall 2014, headcount for Continuing Education fell in Fall 2015 and has continued to decline. Finally, unduplicated headcount for Continuing Education has undergone continuous decline, decreasing 13% from 26,450 in Spring 2014 to 23,424 in Spring 2018.

Figure 1.1. Continuing Education Overall Headcount (Fall)



Headcount by Gender: On average, the female student headcount (66%) was higher than the male student headcount (34%), both remaining consistent between Fall 2013 and Fall 2017. Both the female and male student headcounts decreased 6% and 15%, respectively, between Fall 2013 and Fall 2017.




Figure 1.2. Continuing Education Headcount by Gender

**Headcount by Ethnicity:** The ethnic groups with the largest headcounts between Fall 2013 and Fall 2017 were Latinx students (34%), White students (32%), and Asian/Pacific Islander students (15%), on average. All groups experienced a numerical decline between Fall 2013 and Fall 2017 with the exception of Asian/Pacific Islanders, who increased their representation by 7% over this time period. In terms of proportions, the racial/ethnic makeup of Continuing Education students in Fall 2017 looks similar to the racial/ethnic makeup of Continuing Education students in Fall 2013.




Figure 1.3. Continuing Education Headcount by Ethnicity

**Headcount by Age:** From Fall 2013 to Fall 2017, the age groups with the largest headcounts within Continuing Education were students age 50 and over (44%) and students between ages 30 and 39 (20%), on average. All groups experienced a decline in numbers over the past five fall terms. The overall age makeup of students in Continuing Education has changed little over this time period: 18-24 year olds are somewhat lower represented than they were in Fall 2013 (3%), while students 50 and over increased their proportional representation slightly over the same period (3%).




Figure 1.4 Continuing Education Headcount by Age

**Headcount by Service Area of Residence:** Between Fall 2013 and Fall 2017, on average, the majority of students have come from West City (20%), Mid-City (19%), Outside of the Service Area (18%), North City (16%), and Centre City (16%). Very few students come from Cesar Chavez (1%, on average), although there has been a 12% gain in the number of students coming from this service area since Fall 2013.




Figure 1.5 Continuing Education Headcount by Service Area of Residence

**Headcount by Income Level:** Between Fall 2013 and Fall 2017, on average, almost half of students (46%) reported making between \$0 and \$2,999. The next largest group earned \$33,000 or more (22%). Proportionally speaking, there have been very few changes to the income profile of students attending Continuing Education since Fall 2013. The majority of students attending Continuing Education (between 74% and 78%) make less than the annual living wage for a single adult living in San Diego County as defined by the MIT living wage calculator (\$15.01, or \$31,220.80 for full-time work).





Figure 1.6. Continuing Education Headcount by Income Level

**Headcount by Educational Objective:** Across five fall terms, the most popular educational objectives of students in Continuing Education has been Basic Skills Improvement (27%) and Educational Development (21%). The educational objectives students express for attending Continuing Education have changed little since Fall 2013.

**Headcount by Primary Language:** On average, 64% of the Continuing Education student population reported English as their primary language. By comparison, the districtwide average is 82%.




Figure 1.8. Continuing Education Headcount by Primary Language

**Headcount by Prior Education Level:** From Fall 2015 to Fall 2017, on average, 41% of the Continuing Education student population reported they had earned an AA/AS or higher degree. Almost a third (31%) had no degree, and 27% had never attended college. Over the past three terms, there has been a 13% decrease in the number of students taking CE courses who have no degree. In fact, the loss of these students accounts for the total loss in CE headcount since Fall 2015.




Figure 1.9. Continuing Education Headcount by Prior Education Level

**Headcount by Disability Support Programs and Services (DSPS):** On average, 5% of the Continuing Education student population received disability support services between Fall 2013 and Fall 2017. This is higher compared to the percentage of students served by DSPS districtwide (4%). The number of students who received disability services decreased 1% between Fall 2013 and Fall 2017, while those who had not received disability services decreased 9%.




Figure 1.10. Continuing Education Headcount by Disability Support Programs and Services (DSPS)

Headcount by Day, Evening, & Online Status: On average, between Fall 2013 and Fall 2017, a majority of the Continuing Education student population attended daytime courses exclusively (68%). Less than one quarter of the student population attended evening courses exclusively (20%). Since Fall 2013, there has been a decline in the number of Evening Only (-24%) and Day Only (-11%) students and an increase in the number of On-Campus/Online and Online Only students (138% & 133%, respectively).




Figure 1.11. Continuing Education Headcount by Day, Evening, & Online Status

#### Continuing Education Fact Book 2018 \_\_\_

This section of the Fact Book contains information on student completion (annual awards) which may be considered an indirect assessment of student learning. For purposes of this report, the annual awards conferred are the total number of certificates of completion, high school diplomas, and GED certificates awarded in a single academic year (summer, fall, and spring). Note. Annual awards conferred that are reported in this Fact Book are up to date for all Chancellor Approved Categories. Non-Chancellor approved Award counts can be found in the upcoming Awards Conferred Supplement Report.

All of the information in this section is reported by the following segments:

- 1) Overall
- 2) Gender
- 3) Ethnicity
- 4) Age

**Annual Awards Conferred:** Between 2013/14 and 2017/18, 98% of the total awards conferred at Continuing Education were certificates of completion, and 2% were high school diplomas. No GED certificates were awarded in 2017/18. The number of certificates of completion awarded between 2013/14 and 2017/18 increased 76%, from 5,295 in 2013/14 to 9,342 in 2017/18. This increase is largely due to newly approved programs and additional sections of high demand courses being offered, as well as a focused effort on increasing and submitting completions for all certified classes. Due to the implementation of a new GED testing system, GED certificate data are no longer available as of 2014/15.




Figure 2.1. Continuing Education Overall Annual Awards Conferred



Annual Awards Conferred by Gender: Female students earned 64% of all certificates of completion awarded by Continuing Education in 2017/18 and 62% on average, in the last five years. Female students also earned the greatest share of high school diplomas awarded in 2017/18 (54%) and in the last five years (52%). The number of high school diplomas conferred to male and female students increased until 2015/16, but overall declined 48% for male students and 7% for female students since 2013/14. Certificates of completion have also seen small declines for certain academic years in the last five years, but overall have increased for both male (53%) and female (93%) students since 2013/14.

Annual Awards Conferred by Ethnicity: Latinx students consistently received the greatest share of certificates of completion conferred each year since 2013/14, for an average of 44%. The next greatest shares for certificates of completion were earned by White students (20%), Asian/Pacific Islander students (18%), and African American students (9%). The number of these certificates awarded has increased for all ethnic groups since 2013/14, except for students who reported their ethnicity as other. Latinx students, on average, also received the greatest share of high school diplomas awarded by CE (65%), followed by African American students (13%), and White students (7%). The number of high school diplomas awarded by CE has declined for nearly all ethnic groups since 2013/14.





Figure 2.3.1. Continuing Education Annual Certificates of Completion by Ethnicity








Figure 2.3.3. Continuing Education Annual High School Diploma by Ethnicity





Annual Awards Conferred by Age: On average, the greatest share of certificates of completion awarded were earned by students between 30 and 39 years old (28%), followed by students aged 50 or greater (23%), and students between 40 and 49 years old (22%). The majority of high school diplomas on average, however, were awarded to students between 18 and 24 years of age (63%), followed by students between 25 and 29 (21%), and students between 30 and 39 years of age (13%).



Section III Productivity

#### Continuing Education Fact Book 2018 \_

This section of the Fact Book contains information on productivity measures. The following describes in detail each of the measures:

- 1) Annual FTES. The first measure reported in this section is a measure of productivity. FTES is the total number of full-time equivalent students enrolled. Excludes apprenticeship, fee, and contract classes. F-Factor is included when reported annually.
- 2) Enrollments. The second measure in this section of the report is also a measure of productivity. Enrollments are the number of seats enrolled, or duplicated headcount. Less than one attendance hour and never attends are excluded. Apprenticeship, fee, contract, and cancelled classes are excluded.

**Annual FTES:** Continuing Education showed a slight overall increase in noncredit FTES from 2013/14 to 2017/18. Excluding F-Factor, Continuing Education noncredit FTES increased overall, from 7,921 FTES in 2013/14 to 7,956 in 2017/18. There was no credit FTES for Continuing Education. Including F-Factor, the Continuing Education FTES trend varied, yielding a 0% net change over the 5 years.

Figure 3.1 Continuing Education Annual FTES





Enrollments: Continuing Education enrollment increased from Summer 2013 to Summer 2016, and then decreased in Summer 2017, yielding a 2% net decrease over the 5 years. Overall Continuing Education enrollment decreased 2% between Fall 2013 and Fall 2017, and decreased 8% between Spring 2014 and Spring 2018. Continuing Education enrollments for the online mode of instruction increased 56% between Summer 2013 and Summer 2017, and more than doubled between Fall 2013 and Fall 2017 and between Spring 2014 and Spring 2018.

#### Section IV Human Resources

This section of the Fact Book contains information on the number and classification of employees during the Spring 2018 semester, as of March 31, 2018. The information is reported as follows:

- 1) Employment Type
- 2) Ethnicity
- 3) Gender

**Spring 2018 Employee Breakdown:** There were a total of 983 employees working at Continuing Education during Spring 2018. Over half of the Continuing Education employees were adjunct faculty (57%), followed by non-academic hourly (18%), contract faculty (13%), and classified staff (9%). Supervisory staff and management constituted the smallest proportions of Continuing Education employees (1% each).

The ethnic breakdown showed that White employees comprised 53% of the total employee population, followed by Latinx employees (19%). Asian employees and African American employees constituted 9% and 6%, respectively, of the Continuing Education workforce. Latinx employees comprised 31% of the classified staff and 25% of the non-academic hourly positions. White employees constituted 19% of the classified staff positions, and made up 55% of the contract faculty and 61% of the adjunct faculty positions. White employees comprised 43% of the management positions and 54% of the supervisory positions. Latinx employees constituted 36% of the management positions and 23% of the supervisory positions. African American employees comprised 7% of the management positions and 0% of the supervisory positions.

Figure 4.1. Continuing Education Spring 2018 Employees by Employment Type





Figure 4.2. Continuing Education Spring 2018 Employees by Ethnicity
