# SUMMER 2011 ENROLLMENT MANAGEMENT STRATEGIES

- ⊙ Summer session for the credit program was reduced almost 90% due to an estimated reduction in funding of about 5,000 FTES for 2011-2012.
- ⊙ Reduction of the summer session will allow the colleges to maintain core programs and class offerings for the fall and spring semesters.
- ⊙ The Continuing Education program will proceed with summer class offerings to maintain continuity of its programs. However, the total scheduled class hours for summer will be reduced by more than 50%.



# SUMMER 2011 EXCEPTIONS

- ⊙ Year-round modularized, cohort programs (i.e., Cosmetology, Diesel Technology, Police Academy) will be scheduled, as planned.
- ⊙ MOU agreements with external partnerships will be honored (i.e., SDSU, High School programs, MCAS, Study Abroad) and classes will be scheduled, as planned.
- ⊙ A limited number of general education courses will be scheduled to honor commitments made to pending summer graduates, as well as transfer students with special circumstances.
- ⊙ Pre-season classes for athletic teams that compete in the fall will proceed to ensure the safety of the athletes and viability of the athletic program.



# FALL 2011/SPRING 2012 ENROLLMENT MANAGEMENT AND STUDENT SUCCESS STRATEGIES

- ⊙ Application for Admission Deadline – Fall 2011
  - ⊙ Applications must be filed by August 1, 2011, to ensure students can receive important support services prior to the start of classes, including financial aid.
  - ⊙ Students who apply for admission after August 1, will not receive a registration appointment for fall but can enroll during open enrollment, if space is available.
  - ⊙ Students who apply late will be advised about the availability of important support services for Spring, 2012.



# FALL 2011/SPRING 2012 ENROLLMENT MANAGEMENT AND STUDENT SUCCESS STRATEGIES

- ◎ Concurrent High School Student Enrollment
  - ◎ Concurrent high school enrollment will be temporarily suspended with the exception of special MOU programs (i.e., MET, Accelerated College, Garfield Fast Track, etc.) , as determined by the Presidents.
  - ◎ Goal is to allow for greater access for recent high school graduates who may not have an alternative for college.



# FALL 2011/SPRING 2012 ENROLLMENT MANAGEMENT AND STUDENT SUCCESS STRATEGIES

- ◎ Course Repetition
  - ◎ The number of times a student can “take” a non-repeatable course will be reduced from 4 to 3, effective, Spring 2012, which will align with pending changes to Title 5.



# FALL 2011/SPRING 2012 ENROLLMENT MANAGEMENT AND STUDENT SUCCESS STRATEGIES

- ⊙ Enrollment Registration Priorities (Effective, Spring 2012)
  - ⊙ Continuing Education students who transition to the credit program, and remain continuously enrolled, will be considered continuing students, and receive higher registration priority.
  - ⊙ The following groups will be moved to “last priority.”
    - Students with BA or higher degrees
    - Students with two or more associate degrees
    - Concurrently enrolled university students
    - Students who have completed 100 or more units (students with 72-99 units will also be moved to lower priority)
