# Background

- One of the 22 recommendations of the Student Success Task Force: *Implement a Student Success Scorecard*
- Scorecard replaces the Accountability Reporting for Community Colleges (ARCC)
- Implementation of the Scorecard is required for districts to be eligible for Student Success Act (SB 1456) funding
- Intended to provide broad transparency and accountability

# Summary of Additional Accountability Measures

- Expanded college profile data to include:
  - Total number of sections
    - Credit
    - Noncredit
  - Median class size
  - 75/25 ratio
- All cohort measures are disaggregated by:
  - College-prepared and underprepared
  - Gender
  - Ethnicity
  - Age

# Other Changes

- Added Career Technical Education (CTE) Completion Rate
  - Replaces Vocational Course Completion Rate
  - Defined as completion of eight units in a single CTE discipline; and completion of a certificate, degree or transfer outcome (including transfer-prepared) within six years
- Includes five-year trend data for all metrics
- Peer grouping has been discontinued

# Scorecard Outcome Measures

- Completion Rate
- Persistence Rate
- Completion of 30 units
- Remedial Progress Rate
- Career Technical Education (CTE) Completion Rate
- Career Development and College Preparation (CDCP) Rate – currently the only measure for noncredit programs

All outcome measures are cohort-based and tracked over a specified period of time

<b>City</b>	37%	55%	50%
<b>Mesa</b>	61%	62%	62%
<b>Miramar</b>	58%	72%	68%
<b>Statewide</b>	62%	67%	66%

## Definition

*First-time students in the fall who completed six units, and attempted any math or English course; and persisted in their first three consecutive terms*

# Scorecard Highlights - Continued

<i>Completion of 30 Units</i>			
	<b>Prepared</b>	<b>Unprepared</b>	<b>Overall</b>
<b>City</b>	45%	51%	49%
<b>Mesa</b>	58%	60%	59%
<b>Miramar</b>	69%	68%	68%
<b>Statewide</b>	70%	65%	66%

## Definition

*First-time students who completed at least six units and attempted a math or English course; and earned at least 30 units within six years*

# Scorecard Highlights - Continued

<i>Remedial Progress Rate</i>			
	<b>Math</b>	<b>English</b>	<b>ESOL</b>
<b>City</b>	27%	40%	24%
<b>Mesa</b>	34%	48%	33%
<b>Miramar</b>	36%	46%	22%
<b>Statewide</b>	26%	38%	24%

## Definition

*Percentage of credit students who started below college-level and completed a college-level course in the same discipline within six years*

<b><i>Career Technical Education (CTE) Completion Rate</i></b>	
<b><i>City</i></b>	54%
<b><i>Mesa</i></b>	59%
<b><i>Miramar</i></b>	48%
<b><i>Statewide</i></b>	55%

*Cohort of students who completed eight units in a single CTE discipline within three years; and completed a degree, certificate or transfer outcome (including transfer-prepared) within six years*

# Scorecard Highlights - Continued

<b><i>Career Development and College Preparation (CDCP)</i></b>	
<b><i>Continuing Education</i></b>	5%
<b><i>Statewide</i></b>	12%

## *Definition*

*Students who attempted two or more CDCP courses and completed at least four attendance hours in each course within three years; and completed a degree, certificate or transfer outcome (including transfer-prepared) within six years*

## Methodology

- Records match with Employee Development Department and Unemployment Insurance Wage data
- Cohort-based
  - Students who received an award anytime over 8 consecutive years
  - Students who did not transfer or enroll at another California Community College after receiving award
  - 21 years or older at time of award
- Wages adjusted for inflation to the California CPI
- Average wage represents combined medium wages for the group
- If a student did not have wages 3 years after their award, they are excluded
