- Lynn Neault reported that the drafts have been reviewed by the respective subcommittees of the Student Services Council, as well as by the stakeholders.
- Ailene Crakes reviewed the proposed changes/additions to BP/AP 5110 (Counseling) and BP/AP 5120 (Transfer Center), and agreed to review the procedures in more detail at the next meeting.
- The Council supported all of the policies moving forward to Chancellor's Cabinet and the District Governance Council.

4.0 Review of AP 3100.2

- Chris May, Title IX Coordinator, attended the meeting to review proposed changes to AP 3100.2 Student Disciplinary Procedures, to incorporate a process for sex or gender-based misconduct.
- The changes were reviewed with District counsel as well as outside counsel, the Deans of Student Affairs, and the Student Council.
- The proposed changes eliminate a trial-style hearing for cases involving sex and gender-based misconduct in order to avoid re-victimizing the complaining parties.

5.0 Manual/AP 3200 - Revisited

• The Council agreed to a minor modification to section 1.c.1.g. as follows:

Advisors must ensure that off campus travel is in accordance with BP 3120, Off Campus Student Activities and consistent with section 11 of this procedure.

7.0 Other

- Lynn Neault provided a status report on early filing (October) of the FAFSA.
 The District will not be able to process applications for financial aid earlier, as allowed due to the transition to Campus Solutions. Inquiries to other colleges in the region and statewide indicate that most colleges will not be processing financial aid earlier due to system limitations.
- The Financial Aid Directors have planned an outreach campaign to students that file their FAFSA earlier advising on the next steps. Lynn Neault will send the group the emails.
- In the meantime, in order to accommodate the outreach to students, the Fall 2017 Application for Admission will be available in ISIS in November instead of waiting until March 1, as previously planned.
