2.0 Policy and Procedure Review Session

- Lynn Neault provided the Council with an update on the Student Services
 policies and procedures currently under review. The group of Board policies
 that the Council agreed could move forward have been reviewed by the
 Chancellor's Cabinet and District Governance Council and will move forward
 to the Board for a first reading at the September 22, 2016, Board meeting.
- Those that needed further consultation (Transfer Center, EOPS, Associated Students, Counseling, etc.) have been sent to the stakeholders for review.

3.0 College Promise Planning

 The Council debriefed on the College Promise Program. It was agreed to put together frequently asked questions for the faculty and staff who are working with the College Promise students. Ashanti Hands agreed to put something together for the group to review. The Council recommended the following for 2017-2018:

- Have all College Promise students apply for available scholarships for year 2;
- Require students to file a FAFSA while in high school prior to applying for the program;
- o Involve the Outreach team to visit all of the high schools to promote the program, especially those schools with few applicants this year;
- Move the application process earlier to allow students more time to complete their SSSP services.

4.0 Counselor Workshop

- The Council discussed the tentative agenda and schedule for the November 4, 2016, Counselor Workshop. It was agreed that the workshop would be planned for a full day, 8:30-3:00 and be held at Mesa College. The workshop will focus on the Campus Solutions implementation, with a specific focus on the Counseling/SSSP components. The following tentative agenda was agreed to:
 - Brief introduction of new faculty
 - Introduction of the Campus Solutions Counseling Team
 - Overview of Implementation Timeline
 - Review of Student Portal
 - Overview of Student Self Service
 - Kev features for counselors
 - Highlights of Business Process changes

5.0 Special Part-time Admission

- Home School Students
 - Lynn Neault reported that the Admissions Supervisors are seeing more challenges with the admission of Home School Students. It was recommended that detailed guidelines be developed. The Council agreed to invite the Admissions Supervisors to a future meeting to discuss the challenges and develop guidelines.
