2.0 California Campus Catalyst Grant (Shakerra Carter)

Planning Framework

The Council reviewed a proposed framework for a districtwide grant application for a California Campus Catalyst Grant to bring the information for Dreamer Centers on each of the college campuses. The District is working with designated individuals at each college on the development of the proposal. The grant process consists of two steps: an initial application from which a group is selected to submit a full application. The Council will be kept informed.

3.0 Priority Registration for Athletes (Fall 2018)

The Council was provided the procedures for assigning priority registration to student athletes in Fall 2018 in light of the fact that registration will be in ISIS in Fall 2018, and Campus Solutions in Spring 2019. The Council reviewed the procedures and were in support. The information will be sent to the Athletic Directors for distribution to the coaches.

4.0 Registration Timeline

Fall 2018 and Spring 2019

The Council reviewed and approved the tentative registration timeline for Fall 2018 and Spring 2019. The Council was advised that the dates may change depending upon the final implementation date for Campus Solutions. Lynn Neault will keep the Council informed of any changes.

5.0 Victim Advocacy Grant Program Plan (Chris May)

Chris May, Title IX Coordinator provided the Council with a summary of the programs selected for the new Victim Advocacy Grant that provides victim advocacy coordination and direct support for each of the college and Continuing Education. One purpose of the grant is to provide training to a core team of individuals who serve as campus resources for sexual violence prevention. The next training is in July 2018. Chris May will be working with the designated team to coordinate the training. Chris May also provided a report on the service usage for the Districts Victim Advocate over the past year. Approximately 25-30 individuals utilized the services of the Victim Advocate each semester; 27 were enrolled in ongoing services.

6.0 Health Fee Increase (Revisited)

The Council unanimously approved an increase in the Student Health Fee for 2018-2019 in accordance with state regulations.

7.0 Campus Solutions Implementation Plan Update

The Council was provided an update on the implementation of Campus Solutions. The first phase of financial aid (ISIR loads and communication) has gone live. The Financial Aid staff is positive about the new system, however the Financial Aid Team reports that additional training is needed for future releases.

8.0 Review of Petition for Graduation Deadline Dates (2018-2019)

The Council reviewed and approved the 2018-2019 deadlines for petitioning for graduation. The information will be distributed to staff and posted online.
