- 1.0 Approval of Minutes
  - September 27, 2018

## 2.0 AB 2785

- Proactive Support for Student Lactation Needs
  - Lynn Neault reported that at the last District Governance Council (DGC) meeting it was recommended that the District take a more proactive approach to provide students with information about support for lactation needs.
  - The Council reviewed the requirements for AB 2785, *Student Services: Lactation Accommodations*. Discussion followed.
  - Vice President Adrian Gonzales reported on lactation pods that were used at his former institution. They included a code for use.

- The Council recommended referral to the Health Services for lactation support. There was discussion about proximity to areas of the campus as well as access in the evening.
- The Council agreed to place support materials for students in various areas on campus including DSPS, Health Services, Counseling and Admissions.
- The Council agreed that Lynn Neault would draft a plan for outreach to students and compliance with AB 2785, specifically addressing accommodations, and bring it back to a future meeting.
- 3.0 AB 705 Implementation Status
  - The Council was provided with a brief update on the work of the Districtwide Assessment Workgroup to implement AB 705. The following is being addressed:
    - Use of questions on CCCApply to assign skills levels to new students.
    - Use of Mesa College's Placement Assistant at City and Miramar Colleges for continuing students, International students, and Continuing Education students.
    - Conversion of all existing skill levels to align with AB 705.
    - Communication to students.
- 4.0 Canvas for Orientation Platform (Kats Gustafson)
  - Kats Gustafson reported that the new Canvas Learning Platform has the capability to use online orientation.
  - The Council agreed to discuss further once the new system is live.
- 5.0 Student Health Services Program Denise Whisenhunt (deferred to next meeting)

- 6.0 Service Hours Grids Spring 2019
  - The Council reviewed the Spring 2019 Service Hours Grids.
  - The Vice Presidents agreed to report any changes to Lynn Neault by the end of the week.
  - The Spring 2019 Service Hours Grids will be posted online on Wednesday, November 14, 2018.
- 7.0 BP 3100 Student Rights, Responsibilities, Campus Safety and Administrative Due Process
  - The Council reviewed the updated draft Board of Trustees Policy 3100 Student Rights, Responsibilities, Campus Safety and Administrative Due Process.
  - Updates include additions to the Student Code of Conduct:
    - Inclusion of the prohibition of the use of a recording device in the classroom without consent of the instructor except in cases of Disability Support Programs and Services (DSPS) students with accommodations.
    - Inclusion of a code of conduct violation for providing false information to a college official in the course of an investigation.
    - Inclusion of the prohibition of use, possession, sale and cultivation of marijuana on District premises.
- 8.0 Ongoing Form Review and Update
  - The Council continued the ongoing review and updates of Student Services forms in accordance with the established guidelines. The following forms were reviewed and updated: Counselor Assessed Skill Levels, Deferment Application/Contract, Employee Acknowledgement of Confidentiality of Student Records and Computer Passwords, Petition for Pass/No Pass Option, Mandated Training Course Repetition, Petition for Academic Renewal without Course Repetition, and District Regulations Governing Academic Renewal without Course Repetition.
  - It was agreed that the forms will be updated and distributed accordingly.
