**Student Participation Criteria for
Concurrent College Enrollment**

The following statements are to be reviewed with the high school counselor. Please read the follow statements and sign acknowledging your understanding:

1. The high school counselor and/or site principal/administrator has reviewed the above student's transcript with the student and parent/guardian to ensure appropriate prerequisite coursework has been satisfactorily met and the student is prepared to be successful in a college-level course.
2. The high school administration has recommended the student above attend community college based upon their ability to benefit from advanced scholastic work in accordance with California Education Code Section §48800.5.
 - a. College courses being taken are not available at the high school of attendance
 - b. The high school certifies ADA for the student is claimed in accordance with the law
 - c. The high school certifies, in conformity with California Education Code, no more than 5% of the student's class is participating in concurrent summer enrollment at a community college.
 - d. The high school certifies that this student's enrollment is consistent with the admission regulations herein.
3. If concurrent enrollment outside of the high school day is being requested, the student above has the permission from the site principal/administrator.
 - a. Courses approved for concurrent enrollment, if listed on the high school transcript, will be transcribed as pass/no pass (no letter grades) and will not impact GPA.
4. San Diego Unified requires students to have a minimum cumulative high school Grade Point Average (GPA) of 2.5 or higher; ideally a minimum of 3.0.
5. The San Diego Community College District requires that students maintain a 2.0 GPA in all college coursework.
6. Performance on the English and/or Math college assessment test(s) will determine the student's college course placement, as applicable (e.g., SDCCD Placement Assistance.)
7. Concurrent enrollment in an SDCCD course as a high school student could have an effect on the student's eligibility to apply for college/university (i.e., transfer student vs. first-time student.)
8. Concurrent enrollment in an SDCCD course as a high school student could have an effect on the student's eligibility to apply for financial aid in the future.

9. A plan is in place for the student if he/she drops or withdraws from a college course that is being taken for high school graduation credit.
 - a. Note: parents, guardians, or relatives of the student are not permitted to enroll, drop, or add classes on behalf of the student.
10. A plan is in place for the student if their grade(s) result in academic probation at the college (i.e., takes SDUSD equivalent course(s) for fulfilling high school graduation requirements.)
11. A plan is in place for the student if they earn a substandard grade in a college course being taken for high school credit.
 - a. Note: All grades, including substandard (D, F & NP) grades are permanently reflected on the student's high school and college transcript.
12. Concurrent enrollment in an SDCCD course as a high school student could have an effect on the student's CIF and/or NCAA eligibility.
13. Courses being taken for dual credit will have an effect on both the high school and college GPA, which is reflected on each transcript.
14. The minor student is mature enough to participate in college/university courses and take primary responsibility for their own safety and conduct. The SDCCD colleges are open campuses and are adult learning environments. Curriculum and college processes will not be changed to accommodate high school students. Students must act on their own behalf.
15. Confidentiality laws and California Education Code §49061 prohibits parents/guardians from accessing student records at community colleges without the written consent of the student. College instructors are not required to discuss student performance with parents/guardians. Parents/guardians are to contact the high school if there are questions or concerns regarding student performance.
16. Approved SDCCD partnership programs do not require a student to pay tuition; however, dual and concurrent enrollment may affect a student's ability to receive financial aid in the future.
