- 1.0 Approval of Minutes\*
  - The March 3, 2022 minutes were approved by consensus.
- 2.0 Summer and Fall Service Hours\*
  - Group will have grids done by next week.
  - Group went over the Day Before Thanksgiving and Winter Break
    Group expressed concerns on scheduling
  - Based on student needs Group agreed that light staffing and flexibility in each area would be considered.

ACTION: Jovi to follow up with Danya on Academic Calendars and send to SSC.

- 3.0 Update on 3<sup>rd</sup> Disqualification Suggested Language/Process Change
  - Disqualification form was updated change in progress probation standards:
    - Removed the requirement of college of readmission

- Readmission timeline concerns; 3<sup>rd</sup> disqualification timeline should be different from 1<sup>st</sup>/2<sup>nd</sup> disqualification due to the seriousness of "final chance" but will still assist students to be able to return – group agreed to provide students information and assistance the best we can.
- Group agreed to review registration to move the dates back
- Most students come back in the summer
- Students out for 1 academic year are still active; 1 year and a semester they need to reapply

# ACTION: Group to work on a draft timeline

- Student Services to work with Instruction to finalize dates to move registration for Fall 2023; Summer 2023 around the same time (End of May before semester ends so when they finish Spring they can figure out their next education plan for Fall)
- 4.0 Update on Payment Fees Messaging for Students
  - Cabinet has decided that we are not doing drop for non-payment (Fall 2022)
  - Add/Drop Deadline to be discussed in Advising group's next meeting
    - $\circ$  Suggestion was made to run every 5 days
    - 5<sup>th</sup> day is when the hold is placed
    - Add message to students on next steps to apply for Financial Aid to assist them with their enrollment

ACTION: DeVore to take Add/Drop Deadline to the next Advising meeting

- 5.0 Update on Imaging of Transcripts (Cynthia Rico)
  - Group went over the Transcription Automation Process
    - 1) Smart Panda Take transcript, OCR, loads units, courses into CS
    - Document Imaging will go into Webextender, digital does not go in Webextender – only paper transcripts (Group expressed concerns to move from data center to the cloud)
    - 3) Parchment receives and submits electronic transcripts
  - Adding each college is a manual process
  - Raptor Official Character Recognition
  - This project is our highest priority

ACTION: Keep this on the agenda as a standing item for each meeting; DeVore to send group job aide for paper transcript to help access via Webextender and who to contact for electronic transcripts
