- 6.0 Other
  - Director Fitch shared an update on Disability Support Programs & Services (DSPS) enhancements, including Clockwork, an Interpreting Request Submission Form, and the DSPS Data Dashboard.
  - Dean DeVore shared an update on District Student Services.
    - Fall 2022 communication will be sent to students soon and will include information on updating their gender marker.
    - Student emails will be rolled out gradually to ensure the campuses are adequately supported.
    - HEERF awards will be awarded towards the end of September. The process will be similar to past semesters.
  - District Office Reorganization

- Title IX was approved to be reorganized under Human Resources (Board 8/25/22). It will transition after a full-time Title IX Coordinator position is hired. Some of the student-related functions will remain with Educational Services.
- Accreditation, District Strategic Planning, and Institutional Effectiveness and Research will move to a new Vice Chancellor position (Board 8/25/22). The transition will happen after the new Vice Chancellor is hired.
- Grants will be reorganized under the new Vice Chancellor of Institutional Innovation and Effectiveness position (Board 8/25/22). The transition will happen after the new Vice Chancellor is hired.
- Lillian Garcia, the new Dean, Equity and Special Funded Programs, will begin on 9/6/22.
