1.0 Approval of Minutes

October 6, 2022, minutes were approved by consensus with no edits.

2.0 CVC OEI (Crakes)

- Dean DeVore discussed the Emergency Conditions Allowance Checklist
- There are three reviews by the State Chancellor's office to notify districts that no longer meet all requirements and that their allowance has been permanently rescinded:
 - January 27, 2023
 - o April 28, 2023
 - o December 15, 2023
- A question was raised on how an exchange student from another college is determined on the student transcript. It will be reflected per the teaching institution.
- A question was raised on the units that are counted towards the completion of a degree. If San Diego Community College District (SDCCD) does not have the course, it will not be counted.

3.0 Potential New Student Expense Budget Source

- Based upon all counties in San Diego due to the high cost of living in San Diego
- Financial Aid will oversee this process

4.0 Summer/Fall 2023 Registration (DeVore)

- Dean DeVore's team did an initial analysis and identified a few items that need further analysis.
- Student responses in the Spring will roll over to the following semester.
- Communications to students will be merged to limit the notifications they receive.
- Dean DeVore shared the screens in Campus Solutions that students will access to select their responses to roll over.
- Reminders will be sent to students in advance of registration.
- Request to add search by day/time filter
 ACTION: Dean DeVore to look into adding the filter.
- The question was raised if campuses can clear the prerequisites for students with "course in progress" in good faith. A suggestion was made to provide a "best practices" checklist for counselors to be consistent districtwide.
- The "Apply for Financial Aid" option will be added to the student's "My To-Do" checklist in Campus Solutions.

5.0 Student-Centered Funding Formula – *Standing Item*

- Increase FAFSA numbers
 - The district office is working with campus Outreach to assist students with completing the FAFSA.
