# **DEFINITION**

Under the general direction of the Executive Vice Chancellor, Business and Technology Services, develop and monitor all of the District's annual budgets and audits; and responsible for directing, administering, planning, controlling, organizing and implementing all districtwide fiscal related operational support services, including complex and responsible accounting activities related to the District's financial management and reporting in compliance with established policies and procedures. The Director is responsible for providing a high standard of visionary leadership and direction related to all fiscal operations and administrative services, and other duties and areas as assigned.

# **DISTINGUISHING CHARACTERISTICS**

The Director, Fiscal Services, is the senior-level administrative position responsible for all districtwide fiscal operational areas to include, but not limited to: Budget development and monitoring, Accounting for all fund types, Fixed Asset Accounting, Cash Management, Revenue and Expenditure Control, Accounts Payable, Grants and Contracts, and Financial Reporting. The focus of this management position is on planning, organizing, directing, controlling, managing, and providing direction to directors, managers, supervisors, and their immediate staff of the various functional areas of the Fiscal Services Department within the Business and Technology Services Division. Provides technical expertise and guidance concerning budget, accounting and financial matters, and also provides direction and oversight in operational goal setting, intermediate- and long-term planning, and maintaining approval oversight. The Director, Fiscal Services, provides support to District, campus, and external constituencies, and acts as a liaison through service on committees, and/or workgroups and other duties as assigned.

# **EXAMPLE OF DUTIES**

- 1. Develop and monitor the District's annual budgets and multi-year projections and prepare or monitor the preparation of all related State reports; plan, organize, and monitor all accounting functions of the District and other related fiscal services as assigned.
- 2. Provide coordination, planning, development, and implementation of comprehensive programs related to all functional areas of Fiscal Services.
- 3. Provide leadership and technical support to the Fiscal Services team. Train, supervise, and evaluate the work performance of assigned staff; provide technical direction and guidance; recommend personnel actions, including employment, change in status, and disciplinary action.
- 4. Evaluate and analyze the work efforts, problems, and issues related to all areas of Fiscal Services; develop and implement processes for solutions.
- 5. Develop, implement, and monitor departmental procedures, forms, and regulations to assure efficient and effective practices. Assure compliance with appropriate laws, codes, rules, and regulations and provide for the establishment and maintenance of appropriate fiscal related records and audit trails.
- 6. Direct department staff in planning, developing, and implementing effective programs, business practices, and support services in assigned areas of responsibility.
- 7. Direct the preparation of the District's annual budgets and monitor and control them throughout the fiscal year.

- 8. Direct and participate in the preparation of District financial reports. Prepare multi-year and annual projections of revenue and expense forecasts in determining and monitoring the District's financial position while ensuring compliance with all mandated local, State, and federal reporting requirements.
- 9. Direct the close of the fiscal year, coordinate and oversee all annual contracted audits. Analyze audit reports, prepare written responses, and develop and implement any modifications to accounting systems.
- 10. Ensure compliance with generally accepted accounting principles (GAAP) and all Governmental Accounting Standards Board (GASB) pronouncements.
- 11. Direct the preparation of all necessary financial agreements for the District, including banking relationships, audit contracts, financing agreements, and any agreements necessary to assist in providing funds to meet the District's cash flow requirements.
- 12. Maintain proper accounting controls over all District revenue and expenditures and ensure compliance with all appropriate internal controls.
- 13. Develop, coordinate, maintain, and recommend improvements and modifications to ERP systems and associated applications related to all Fiscal Services functionalities.
- 14. Implement and coordinate the Diversity and EEO compliance policies and requirements related to areas of responsibility.
- 15. Prepare reports and make recommendations to the Executive Vice Chancellor for Board, Chancellor, and Cabinet members; communicate districtwide, fiscal related support services and operational issues/matters as legally required and/or directed.
- 16. Serve on various District taskforces, committees, and councils as directed. Attend local, State, and national conferences as directed.
- 17. Serve as Acting Administrator for Business and Technology Services Division as assigned by the Executive Vice Chancellor.
- 18. Perform related duties as assigned.
