2.0 Student Success Planning

- The Council was provided with a revised draft comprehensive plan for student follow up notices based upon various student academic characteristics.
- The Council reviewed and made minor changes.
- The Council agreed and approved the timeline for email follow up notices.
- At the October 2, 2014, Student Services Council meeting, the Council was provided with a draft planning agenda for Student Success and Equity: Improving Student Outcomes 2014-2015. The Council agreed to continue their planning discussion at this meeting.

- The Council agreed to add additional overarching goals: to increase students that achieve key momentum points including: 30 units completed completion of college-level English and math, and completion of certificate, degree, and transfer; and to align class scheduling with student educational planning.
- It was agreed to bring the proposal to pilot preregistration in math to the Math meeting on November 12, 2014.

- The Council was provided with the concurrent high school student report for 2009/2010 2013/2014, categorized by: ACP, regular concurrent enrollment, and non-state supported. Discussion followed.
- 4.0 Violence Against Women Act (VAWA) Action Plan for Students
 - The Council was provided with a draft Violence Against Women Act (VAWA)
 Action Plan. The VAWA was passed two years ago and should be fully
 implemented this year.
 - The plan includes the following:
 - Update Board Policy 3100 and procedures.
 - Identify person on campus where students can report incidents of sexual assault (Title IX Coordinator).
 - Determine clear expectations for college/district responsibility and follow up for incidents that occur off-campus, unaffiliated with the college.
 - Develop education and prevention programs for all new students and continuing students.
 - Develop process for reporting incidents that occur on campus or at districtsponsored events.
 - Compile comprehensive list resources for victims of sexual violence.
 - o Plan risk reduction information campaign each academic year.
 - Inquiry component where students can report anonymously, assess what is going on.
