The Campus Solutions team leads are in the process of reviewing the gap analysis. The analysis includes the identified gap and recommended solutions including business process changes, adding new programming or data fields. The teams will resume their work in February.

ASSOCIATE DEGREE FOR TRANSFER E-VERIFY

In 2011, the legislature approved SB1440 which created the Associate Degree for Transfer (ADT or AA-T or AS-T). Since that time 24 degree programs have been approved statewide and 16 new programs in the District (City-16, Mesa-15, Miramar 15).

Students who earn this degree are guaranteed admission to a California State University (CSU), although it may not be their CSU of "choice." Additionally, students at a CSU who earn an Associate Degree for Transfer are guaranteed to earn a bachelor's degree after completing 120 units.

Since 2011, the district has seen a significant increase in the number of students earning these transfer degrees. For example, in 2012-13, the district awarded 146 ADT degrees, and in 2013-14, the number increased to 483. Currently there are 1,471 City, Mesa and Miramar college students who have applied to transfer to a CSU in the Fall indicating they will earn an Associate Degree for Transfer. The CSU system office has developed an "e-verify website" used by all California Community Colleges to indicate whether students are on track for Spring 2015 degree completion or not. The District evaluators will complete the e-verify process for all students on the CSU list by the March 15th deadline.

1098-T TAX FORMS

The 2014 1098-T tax form (tuition statement) is available for download now on the [e-Tax](#) site, for eligible students who selected "Electronic" delivery of the form (information is also posted on [Student Web Services](#)). Eligible students received e-mail instructions on how to download their form on January 20th.

The 1098-T form will be mailed out to students who selected "Paper" delivery on Thursday, January 29, 2015.

Beginning this year, international students with "D" numbers (instead of an SSN) will **not** have a 2014 1098-T tax form automatically produced for them. International students who do not have an SSN can request a manual 2014 1098-T tax form by sending an e-mail request to etax@sdccd.edu
